Ready to Roll Giveaway Sweepstakes

- 1. NO PURCHASE, PAYMENT OR SUBMISSION TO SALES PRESENTATIONS NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.
- 2. **Sponsor**: The Radio Flyer Ready to Roll Giveaway Sweepstakes (the "Sweepstakes") is sponsored by Radio Flyer Inc. (the "Sponsor").
- 3. **Official Rules**: These are the official rules (the "Official Rules") for the Sweepstakes. By entering any of the Sweepstakes, entrants agree that they can be contacted by phone or email regarding the Sweepstakes, and to be bound by these official rules and all decisions of the Sponsor relating to the Sweepstakes, which shall be final and binding on entrants.

- 7. **Determination of the winner**: One (1) grand prize winner for each day will be randomly selected from those eligible entries received each day of the sweepstakes. A Provisional Winner for each day will be selected on or about ten (10) days after the end of the daily drawing (the "Drawing Date"). The Provisional Winner will be notified by phone or email. If the Provisional Winner does not respond within fourteen (14) days of the date appearing on the prize notification, or fails to comply with the instructions contained in the prize notification within that time period, Sponsor reserves the right to randomly choose an alternate winner from the pool of remaining eligible entries. The first eligible Provisional Winner that Sponsor successfully contacts in person by telephone or by email and who claims the Grand Prize in accordance with these Official Rules will be declared the final Winner. The Winner may waive the right to receive a prize. The return of any prize,
